During FY 2022, the Land Trust of North Alabama (LTNA) continued programs in furtherance of our mission to protect and preserve land and its legacies for conservation, public recreation advocacy and conservation education. The LTNA conserved an additional 516 acres in 2022, bringing the total of owned and managed conservation property to over 9800 acres. LTNA also provided a wide range of nature-based education and recreation opportunities, including field trips, on-campus school programs, and guided hikes. All 8 of our nature preserves are open daily for people to enjoy activities including hiking, biking, wildlife viewing, photography, picnicking, bird watching and fishing. Two of our nature preserves also allow horseback riding opportunities.
